Iqaluit, Nunavut Nunavumi Nutaqqanut Inulramirnullu Uqaqtikhaanik havitiyuq havakvimit hivuliqmiq aipagutuaraagat unipkaamik Maligaliuqvikmi Nunavumi ublumi. Unipkaaq uqauhiqaqtuq naini (9) tatqiqhiutini aulaniqmi: June 16-mi 2014-mi, Nunavumi hivuliq Nutaqqanut Inulramirullu Uqaqtikhaanik havaliqman, nuginiganut 2014-mit 2015-mut aulaniqmi ukiumi. Unipkaaq pijutiqaqluaqtuq havakviup hivuliit upalugaiyautainik tungavikhainiklu havaanik, atuqnigaqmat havakviup ukiuqnigiganut September 30-mi 2015-mi.

"Agiyuraalukmiq havaakhaqaqtuq hivunikhaq pivagiagani inulramiit Nunavumiutat piyunnaitauyut inuhiqatiaqnigilu munariyauyaagani. Kihiani, quviahuktuga tungaviliuqtaptiknik, havakhimagineqtugut, ikayutauniaqmat taja ayuruirutiptiknik ikayuriagani nutaqqt, inulramiit, ilagiyailu pinariqpakligit ihuaqtumiklu," Uqaqtikhaanik, Sherry McNeil-Mulak, uqaqtuq.

Akmakniganit, havakviat ikayuqtuvaktuq 61-nik inuknik inulramiqnik Nunavumiutanik, pulaaqhutik qulinik nunagiayunuk, amigaituniklu uqaqviqaqhutik hivuniqhijutiniklu pipkaivlutik katimaniqani ilauyulu ilagikmagu hivuani inuknik upijutainik havaami. Havakviat hivuani ilitaqhijihimaliqtuq ilaliutivalialutik havagumakmata agiyuutilugu havaakhitaujutigiyatik akmaqaqmata – aulaqtiriaqhutii humagiluaqhugu ikayuqtuiniq atuni nutaqqanik inulramiqniklu, qauyipkaivaaliquhutiklu havakvianik nutaqqalu piyunnaitayunuk. Qauyipkagauyuni aipagutuaraagat unipkami, RCY-m havakviata ilitaqhijiyut amigaitqiyanik 2-hanat agiyaqtunit agiyunut havaanik iniqtiriaqatunik havakviat akmariqtinagu.
