## **INUNGNUT TUHAQTIDJUTIKHAQ**

### **Havaktinga Nutaqqanut Inuulramiinullu tuhaqtitiyuq Qanuriliurninganik Inulramiyyunun Nunavunmiutauyut 2019-2020 ukiuk tamaat unigtuirutikhaq iniqhimayuuq titiraq**

**Iqaluit, NU** – Ilagiyainik talvuuna Havagviat Nutaqqanut Inulramirnullu (Uqaqtikhaanik) 2019-2020 unigtuirutikhaq iniqhimayuuq titiraq, havakhimaaqpakhimayut talvanga Havaktinga Nutaqqanut Inuulramiinullu Havagvingnin (RCYO) tuniyaangat naunairutikharnik qanuritaakhaani ituq inulramiyyaangat Nunavunmiutmi, talvuuna katitiginikkut Nunavut Kavamanga (GN) ikayuktiuhimaaqtunik havaktinin.

Tamna hanaqidjutitaaq talvuuna Qanuriliurninganik Inulramiyyunun Nunavunmiutauyut havagviangit imailugianganik "tuniyaangat naunaitkutikharnik atuqtaugiaqaqtunik tapkuninga GNkut ihumaliurniaqtunik ilituqhaiyaangatlu ihumaliuqhimayainik ikayugianganik tuniyaangat naunaitumik, havaqatigiikharnik aturniaqtun ihuatqiyayuumik hivumuugianganik", uqallaktuq Havaktinga Nutaqqanut Inuulramiinullu, Jane Bates.

Talvuuna naunairutikharnik pihimayut talvanga nutaqqat inulramiinulu ikayukhimaqtun Gn-kutni havagviangit uvani havagvingmi, naunaituq atuqtauyukharnik naunairutikharnik ukuninga GNkutni havagviata munagiyauluungitun ihuaqtumik, aulahimaaqhimaitumik, talvuunalukiak, naunairutiqaqhimayut havagviangit atugakhangitni. Ilanganin hulilukaaktukharnik, ihualuungitunik naunairutingnik tuniyauhimayut talvanga havagviangit titiqidjutitiliqinikkut. Kihititirutikhat tuniyauvakhimayut naunairutiqaqtun taima amigaitun havaktauyukhat ikayuutikharnik munagidjutikharniklu Nunavutim inulramiingit. "Havagviangit aulahimaalimaitun nanminikkut ihuaruhuktukhaungitun talvuuna akhurnaqtumik havakhimaaqtamingnik inuuhiatigun inulramiyyut Nunavunmiuyut ilagiyangitlu," uqallaktuq Bates.

Uvani Titiraqhimayuni talvanga Ilauquyauhimayunin havagvianin uvani ukium iniqhimayuuq ilitugidjutikhaq titiraq, Bates katitiqhimavakhimayuuq Kihititirutikhangit Inulramiyyut Nunavunmiutat havagviangit ilitugidjutikharnik tautukhimayainiklu naunairutiqaqhimayuuq talvanga havagviangit havaktamingni, talvuuna havakpakhimayainik hivulliyut ukiungit Havaktiupluni talvani.

"Tapkuat pingahuuyut qanuriliurutit iitugipkaktauhmayut uvamnun ilangit Nunavut Kavamanga havaktiit kiuyauluungitun ihumaliurhimayainik unalu/unaluuniit qanuriliuqpakhimayainik; kiyyaangat iituhaiyaangatlu ayuqhaqtitiqaqtunik ilangit nutaqqat akuktauvakhimayut aulahimaaqtun; unalu namaniqaqtuuq atuqhimaaqtamingnik 'taimainami Ukiuktaqtumi' unalu hanaqidjutikharnik piqaqtukhaungituuq atuqtakharnik ilihaiyaangat aulahimaaqtunik ayungnautit."
