Iqaluit, NU – Havaktiuyukhaq Nutaqqanut Inuulrammiinullu Havakvinga (RCYO) tunngahuktittiyuq Jane Bates nutaaq Havaktiuyukhaq Nutaqqanut Inuulrammiinullu (Havaktiuyukhaq). Bates tikkuaqtauyuq Havaktiuyukhaq auyalihaalitilluni Kamisinauyumit Nunavunmit pitquyauninnganik Maligaliurvikmit Nunavunmi, taimaa tallimanik ukiunik havaariyakhaa.

“Ilitariyara akhuerutiuyuq havaaq taimaa Havaktiuyukhaq,” uqaqtuq Bates. “Quviagiyara pivikhaqautikhaq ikayuriami angikliyuumiriami nipingit inuulrammiit nunavunmi naunairiamti nakuutqiangit piumayanginnik piyait, inmikkut atautikkullu.”

Bates ilauyuq RCYO qauymadjutinga piqaqpiaqtuq ikayuriami nakuutqiamik piumayanginnik inuulrammiit ilangillu. Pihimaya Naunaitkutaliriniq Ulaasiliqinirmut naunaikuttinga Ryerson Iliharvikyuanganit, pilihaalitaa ayuittiaqtuq havaanga ilanginnut ulaasiliqiyii uumunnga Peel Nutaqqat Ikayuqniqmut Katimayiingit. Bates talvannga nuuttuq Yukon-mut, talvani havaktuq amihumik angayukhiq havaanga inuulrammiinut ilanginnullu ikayutikhaq, taimaa utiffaarmat Ontario-mut. Bates piqaqtuq ayuittiaqtumik iliharniq ayuitaminiklu nutaqqanik hapummiutiniq, ilangillu ikayutikhaq, inuulrammiit ihuarhainiq, qilamiuqtuqaliqqat nutqaqtittiniarniq, mamihainiqmut nunallaat katimaniq, unalu qayangnaqtumik pipkaidjutimut ihivriuqniq.
