Nutaqqanut Inulramirnullu Uqaqtikhaanik Havakviata Haavitait Hivuliq Aipagutuaraagat Unipkaa

RCY-mi taja ikayuqtikhanut havaaq havaariyauyuq tungaviquaqhuni uqautauyunik 2014-mit 2015-mut unipkaami

Iqaluit, Nunavut Nunavumi Nutaqqanut Inulramirnullu Uqaqtikhaanik havitiyuq havakviminit hivuliqmik aipagutuaraagat unipkaamik Maligaliuqviki Nunavumi ublumi. Unipkaa qauhiqaqtuq naini (9) tatqiqhiutini aulaniqmi: June 16-mi 2014-mi, Nunavumi hivuliq Nutaqqanut Inulramirnullu Uqaqtikhaanik havaliqman, nuguniganut 2014-mit 2015-mut aulaniqmi ukiumi. Unipkaa pijutiqaqluqtuq havakviup hivuliit upalugaiyautainik tungavikhainiklu havaanik, atuqniqaqmat havakviup ukiuqniqiganut September 30-mi 2015-mi.

“Agiyuraalukmik havaakhaqaqtuq hivunikhaq pivagiagani inulramiit Nunavumiutat piyunnaitauyut inuhiqatiaqnigilu munariyauyaagani. Kihiani, quviahuktuga tungaviliuqtaptiknik, havakhimaginaqtugut, ikayutauniaqmat taja ayuruirutiptiknik ikayuriagani nutaqqat, inulramiit, ilagiyailu pinariqpaklugit ihuaqtumiklu,” Uqaqtikhaanik, Sherry McNeil-Mulak, uqaqtuq.

Akmakniganit, havakviat ikayuqtuivaktuq 61-nik inuknik inulramiqnik Nunavumiutanik, pulaaqhutik qulinik nunagiyauyunik, amigaituniklu uqaqviqaqhutik hivunihijutiniklu pipkaivlutik katimaniqani ilauyulu ilagikmagu hivuani inuknik upijutainik havaami. Havakviat hivuani ilitaqhihimaliqtuq ilaliutivalialutik havagumakmata agiyuutilugu havaakhitaujutigiyatik akmaqaqmata – aulagtiriaqhuti ihumagiluaqhugu ikayuqtuiniq atuni nutaqqanik inulramiqniklu, qauyipkaivaaliquhutiklu havakvianik nutaqqalu piyunnaitauyunik. Qauyikagaayuni aipagutuaraagat unipkami, RCY-mi havakviata ilitaqhiyut amigaitqiyaniq 2-hanat agiyaaqtunit agiyunut havaanik iniqtiriaqaqtunik havakviat akmariagtinagu.

Uumiga Uqaqtikhaanik: Nutaqqanut Inulramirnullu Uqaqtikhaanik munariyuq pivaaligtitugilu piyunnaitauyut Nunavumi nutaqqanik inulramiqniklu.
